DEVELOPMENT

- In January 2015, West and Cohen had the idea of making a feature documentary about Ruth Bader Ginsburg. They had both, separately, interviewed the Justice for projects in the past, and had both admired her trailblazing work for women's rights.
- January 2015 they wrote Ginsburg an email asking if they could make a film about her life. Her answer was basically "not yet"
 - West and Cohen, were disappointed but reached out to her again in a few months
- This time, Ginsburg gave them the go-ahead to begin filming but warned them that she wouldn't be able to be interviewed for the film for at least 2 years (a promise she made good on)
- West and Cohen sent her a list of people they wanted to interview including family members, former clients, colleagues and friends
- At that time, Ginsburg also gave permission for them to start filming her at events, such as the opera, her office and speaking engagements
- Then in 2017, they asked for more access. Ginsburg gave permission for them to begin filming her at home and at the gym

STORY/TOPICS

- RBG is a revelatory documentary exploring Ginsburg's exceptional life and career from Betsy West and Julie Cohen, and co-produced by Storyville Films and CNN Films
- Ginsburg was a pioneer for equality among men and women
- She is a brilliant lawyer and dedicated wife and mother that had to work incredibly hard for everything she has achieved
- Ginsburg is something of a pop culture icon now and role model for young people

ABOUT RBG

- Joan Ruth Bader was born on March 15, 1933 in Brooklyn, New York
- Ginsburg and her husband Marty married in 1954, they had two children together
- After the birth of their daughter, her husband was diagnosed with testicular cancer. During this period, Ginsburg attended class and took notes for both of them, typed her

husband's dictated papers and cared for their daughter and her sick husband—all while making the Harvard Law Review

- She graduated from Columbia Law School, tied for first in her class in 1959
- Ginsburg taught at Rutgers University Law School (1963–72) and at Columbia (1972–80), where she became the school's first female tenured professor
- As a lawyer, she went on to become a staunch advocate for the fair treatment of women
- One of the five cases she won before the Supreme Court involved a portion of the Social Security Act that favored women over men because it granted certain benefits to widows but not widowers. This landmark case proved that she believed in total gender equality and was willing to fight for it
- Ginsburg was appointed by President Carter to the U.S. Court of Appeals in 1980 and was appointed to the Supreme Court by President Clinton in 1993, only the second woman to be appointed to this position
- In 1999, Ginsburg was diagnosed with colon cancer; she underwent surgery that was followed by chemotherapy and radiation therapy. During the process, she did not miss a day on the bench
- In June 2010, Ginsburg's husband, Marty, died of cancer. She described Marty as her biggest booster and "the only young man I dated who cared that I had a brain." They had been married for 56 years at the time of his passing.
- A day after her husband's death, she was at work on the Court for the last day of the 2010 term
- When John Paul Stevens retired in 2010, Ginsburg became the oldest justice on the court at 77
- Despite rumors that she would retire because of advancing age, poor health and the death of her husband, she denied she was planning to step down

CAST:

Ruth Bader Ginsburg

- Ginsburg is an Associate Justice of the Supreme Court of the United States.
 - She was appointed by President Bill Clinton in 1993, becoming the second female justice on the U.S. Supreme Court
- She obtained her bachelor's degree from Cornell. Ginsburg was a wife and mother before starting law school at Harvard, where she was one of the few women in her class. She transferred to Columbia Law School, where she graduated tied for first in her class
- "Meeting RBG in person is a powerful experience. Her voice is soft, but her words are so clear and carefully chosen that you find yourself drawing closer, riveted," West and Cohen said
- "[Ruth is] the closest thing to a superhero I know," -Gloria Steinem, women's rights activist and friend of Ginsburg
- "I became a lawyer when women were not wanted by the legal profession," -Ginsburg, who enrolled in Harvard Law School in 1956

• Ginsburg has always been a champion for human rights, she worked at the American Civil Liberties Union in the 1970s and co-founded the Women's Rights Project

Jane and James Ginsburg

- Daughter Jane is the Morton L. Janklow Professor of Literary and Artistic Property Law at the Columbia Law School
- She is married to George Spera and they have 2 children together
- Justice Ginsburg and Jane are the first mother–daughter pair ever to serve on the same law faculty in the United States
- Son James is a music producer. He is the founder and president of Cedille Records, a classical label, which was launched in 1989 when Ginsburg was a student at the University of Chicago.
- Even though James comes from a family of lawyers he only attended law school for one year

Clara Spera

- Ginsburg's granddaughter, Clara, is following in her footsteps. She attended Harvard Law School where she focused on "gender discrimination, reproductive justice, and the legal issues surrounding the adjudication of campus and military sexual harassment"
- Spera is now a Law Clerk for the Southern District of New York
- "[M]y birthday party wasn't held there to show off or because the Court's such an impressive space; it was because she wanted me to know, from the age of three, that my grandmother, my Bubbie, worked there, and that I shouldn't consider anything out of my reach." -Clara Spera

Gloria Steinem

- Colleague in the women's rights movement
- Known for The First Wives Club, V for Vendetta and The Good Wife

Nina Totenberg

- American legal affairs correspondent for National Public Radio
- Known for Dave, The Distinguished Gentleman and Original Intent: The Battle for America

Lilly Ledbetter

• RBG's famous dissent in Ledbetter's case led Congress to pass a law rectifying pay discrimination against women

Irin Carmon and Shana Knizhnik

- Authors of "Notorious RBG: The Life and Times of Ruth Bader Ginsburg"
- Law-student Shana Knizhnik was the creator of the Notorious R.B.G. Tumblr
- She teamed up with MSNBC reporter Irin Carmon to turn the blog into a book titled "Notorious RBG: The Life and Times of Ruth Bader Ginsburg."

• It was released in October 2015, the book became a New York Times bestseller

When, after graduating at the top of her law school class, she could not get a job, she remembered her mother's advice: anger is a waste of time. Eventually, she was able to use her formidable legal skills to fight for justice for women--a fight she has continued through five decades."
- Betsy West is an award-winning filmmaker, journalist and educator.
- Julie Cohen is a producer and director, known for The Sturgeon Queens and American Veteran
- Betsy West is a producer and director, known for MAKERS: Women Who Make America Video Archive (2012), The Lavender Scare (2017) and Constantine's Sword (2007)
- West was a producer and executive for over two decades at ABC News
- West received 21 Emmy Awards and two duPont-Columbia Awards for her work on "Nightline" and "PrimeTimeLive" and the documentary program "Turning Point"
- As senior vice president at CBS News from 1998-2005, she oversaw "60 Minutes" and "48 Hours"
- West was executive in charge of the CBS documentary 9/11, winner of the Primetime Emmy Award in 2002
- In 2007, she joined the faculty at the Columbia University Graduate School of Journalism, where she is the Fred W. Friendly Professor of Professional Practice in Media and Society

TRIVIA

- Ginsburg's profile began to rise after Justice Sandra Day O'Connor's retirement in 2006 left Ginsburg as the only serving female justice. Her increasingly fiery dissents led to the creation of the Notorious R.B.G. Tumblr and meme comparing the justice to rapper The Notorious B.I.G.
- Ginsburg's pop culture appeal has inspired nail art, Halloween costumes, a bobblehead doll, tattoos and a coloring book among other things.
- Since 2015, Ginsburg has been portrayed by Kate McKinnon on Saturday Night Live

• In the film *Deadpool 2*, a photo of her is shown as Deadpool considers her for his X-Force, a team of superheroes

PRODUCTION/CINEMATOGRAPHY Storyville Films and CNN Films

- Began filming in June of 2016
- Filmed Ginsburg in her office, on vacation with her family and working out with her personal trainer
- Additionally, the directors tracked down clients that Ginsburg represented as a young lawyer arguing before the Supreme Court in the 1970's
 - RBG's brilliant legal strategy resulted in five groundbreaking rulings that made great strides towards putting women and men on an equal footing before the law.
- Claudia Raschke was the Director of Photography
- Waiting until the very end of filming to finally interview Ginsburg proved to be the best decision
 - By the time Cohen and West finally sat down with Ginsburg, they had already learned so much about her through the eyes of her closest friends and family members

EDITING/VFX (Carla Gutierrez)

• Gutierrez is the editor of the Oscar-nominated documentary *La Corona*, and the Emmy-nominated *Reportero* and *Kingdom of Shadows*

SOUND/MUSIC (Miriam Cutler)

- Cutler is an Emmy-nominated composer
- Known from *The Hunting Ground, Ethel, Lost in La Mancha, Thin, Poster Girl, Vito, Kings Point, Ghosts of Abu Ghraib, A Plastic Ocean* and more
- The movie begins with sound clips about Ginsburg from some of her critics, this sets the stage for how much adversity she has faced and still faces today
